

Mud Dog Run – Waiver and Release of Claims, Assumption of Risk and Warning of Risk

The Mud Dog Run is owned and operated by Clickit Events, LLC.

Please initial on each line after reading

- 1. I understand that entering the Mud Dog Run is a hazardous activity.
- 2. I understand that Mud Dog Run presents extreme obstacles including, but not limited to, mud pits and steep hills and water. I also understand there will be people chasing me disguised as Zombie throughout the obstacle course.
- 3. I agree to not consume alcohol prior to Mud Dog Run or ingest any medicines or substances that will inhibit my mental or physical ability to safely and effectively participate in Mud Dog Run.
- 4. I agree not to participate unless I am medically fit and able.
- 5. I agree to abide by any decision of a race official concerning my ability to safely complete the race.
- 6. I agree to obey all civil and criminal laws at all times.
- 7. I assume all risks associated with competing in Mud Dog Run, including but not limited to falls, contact with other participants, negligent or wanton acts of other participants, completing all obstacles, defects or condition of premises, the effects of the weather, including high heat and/or humidity, all such risks being known and appreciated by me.
- 8. I agree that CLICKIT EVENTS, LLC, Crumland Farms are not responsible for any personal items or property that are lost or stolen in the gear check area.
- 9. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency.
- 10. I understand and will abide by the rule that no wheeled baby conveyances or other wheeled means of conveyance, or pets are permitted in the race.
- 11. I grant permission to CLICKIT EVENTS, LLC, Crumland Farms, its affiliates, sponsors, and assigns to use any photographs, motion pictures, recordings or any other record of this event for any purpose including but not limited to promoting, advertising and marketing purposes. Any CLICKIT EVENTS, LLC photography, motion pictures, recordings or other records of the event are the sole property of the Mud Dog Run and CLICKIT EVENTS, LLC.
- 12. The official race Administrators reserve the right in any event of emergency or local or national disaster to cancel the race and in the event of cancellation or change there is no refund of entry fees.
- 13. Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all people, equipment, and facilities, and cooperative, positive participation. Mud Dog Run reserves the right to dismiss, without refund, anyone whose behavior endangers safety or negatively endangers safety or negatively affects a race, a person, a facility, or property of any type or kind. I also agree to indemnify CLICKIT EVENTS, LLC, its affiliates and assigns, from any and all third party claims caused in whole or in part by my actions.
- 14. I understand that all entries are final. There will be no refunds

I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in these activities against CLICKIT EVENTS, LLC, including its officials, agents, volunteers, sponsors, and employees (hereinafter collectively referred to as CLICKIT EVENTS, LLC, or Mud Dog Run). I do hereby fully release and forever discharge CLICKIT EVENTS, LLC, Crumland Farms, from any and all claims for injuries, illnesses, damages, expenses, or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with the race, program or activities. I have read and fully understand the above information, warning of risk, assumption of risk and waiver and release of all claims. When registering online, my online signature shall substitute for and have the same legal effect as an original form signature. **PARTICIPATION WILL BE DENIED**, if the signature of an adult participant or parent/guardian and date are not signed at the time and place of the race. CLICKIT EVENTS, LLC, LLC is committed to conducting its race and activities in a safe manner and holds the safety of participants in high regard. CLICKIT EVENTS, LLC continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participants' safety. However, participants and parents/guardians of minors registering for the race, programs/activities must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs. I am solely responsible for determining if I or my minor child/ward is physically fit and/or skilled for the race or activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant or disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity. I do hereby fully release and forever discharge CLICKIT EVENTS, LLC, Crumland Farms, from any and all claims for injuries, damages or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with these programs/activities.
