- _____ 3. I agree to not consume alcohol prior to Mud Dog Run or ingest any medicines or substances that will inhibit my mental or physical ability to safely and effectively participate in Mud Dog Run.
- _____ 4. I agree not to participate unless I am medically fit and able.
- _____ 5. I agree to abide by any decision of a race official concerning my ability to safely complete the race.
- _____ 6. I agree to obey all civil and criminal laws at all times.

I assume all risks associated with competing in Mud Dog Run, including but not limited to falls, contact with other participants, negligent or wanton acts of other participants, completing all obstacles, defects or condition of premises, the effects of the weather, including high heat and/or humidity, all such risks being known and appreciated by me.
- _____ 8. I agree that CLICKIT EVENTS, LLC, Crumland Farms are not responsible for any personal items or property that are lost or stolen in the gear check area.
- _____ 9. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency.
- _____ 10. I understand and will abide by the rule that no wheeled baby conveyances or other wheeled means of conveyance, or pets are permitted in the race.
