Assumption of Risk and Warning of Risk**

- \_\_\_\_\_ 1. I understand that entering the Mud Dog Run is a hazardous activity.
- \_\_\_\_\_ 2. I understand that Mud Dog Run presents extreme obstacles including, but not limited to, mud pits and steep hills and water. I also understand there will be people chasing me disguised as Zombie throughout the obstacle course.
- \_\_\_\_\_ 3. I agree to not consume alcohol prior to Mud Dog Run or ingest any medicines or substances that will inhibit my mental or physical ability to safely and effectively participate in Mud Dog Run.
- \_\_\_\_\_ 4. I agree not to participate unless I am medically fit and able.
- \_\_\_\_\_ 5. I agree to abide by any decision of a race official concerning my ability to safely complete the race.
- \_\_\_\_\_ 6. I agree to obey all civil and criminal laws at all times.
- \_\_\_\_\_ 7. I assume all risks associated with competing in Mud Dog Run, including but not limited to falls, contact with other participants, negligent or wanton acts of other participants, completing all obstacles, defects or condition of premises, the effects of the weather, including high heat and/or humidity, all such risks being known and appreciated by me.
- \_\_\_\_\_ 8. I agree that CLICKIT EVENTS, LLC, Crumland Farms are not responsible for any personal items or property that are lost or stolen in the gear check area.
- \_\_\_\_\_ 9. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me. This Release extends to any liability arising out of or in any way connected with the medical treatment and transportation provided in the event of an emergency.
- \_\_\_\_\_ 10. I understand and will abide by the rule that no wheeled baby conveyances or other wheeled means of conveyance, or pets are permitted in the race.

I grant permission to CLICKIT EVENTS, LLC, Crumland Farms, its affiliates, sponsors, and assigns to use any photographs, motion pictures, recordings or any other record of this event for any purpose including but not limited to promoting, advertising and marketing purposes. I also agree to indemnify CLICKIT EVENTS, LLC, its affiliates and assigns, from any and all third party claims caused in whole or in part by my actions.
